It can't get any easier!

As the employer you specify the discount rate and establish the monthly quota per staff member.
Amounts up to CHF 180.– per month are exempt from social security contributions and tax.

You mail us your staff's address data.

The Reka sends all information and documents to staff members' private addresses – including an accompanying letter in their name.

Staff members pay their share using the pay-in slip. The employer's share (discount) is included and credited to the corresponding Reka-Lunch account.

The Reka sends the staff members the loaded Reka-Card and access to their own account.

The Reka sends them a monthly statement.

Statement sample

The following statement sample represents a company with 100 employees.
The monthly quota amount is CHF 100.– on which the employer grants a 50 % discount.
